Warranty Documentation

Power Mover (All Models)

Ultra-Fab Products makes the following warranty with respect to the named product. This Warranty is made only to the first Purchaser (hereinafter called the "Original Purchaser") who acquires this product for their own use.

Ultra-Fab warrants this PowerMover to be free from defects in material and workmanship under normal use and service for which the machine was intended for a period of one year from date of purchase by the Original Purchaser. It is suggested that the Original Purchaser retain a copy of the dated bill of sale as proof of the date of purchase and/or register the warranty at ultra-fab.com/warranty/.

This Warranty does not cover conditions unrelated to the material and workmanship of the product. Such unrelated conditions include, but are not limited to (a) the need for normal maintenance and any damage resulting from the failure to provide such maintenance; (b) failure to follow Manufacturer's instructions for use of this product, and (c) any accident to, or misuse of, any part of this product and any alteration by anyone other than the Ultra-Fab or its authorized representative. This warranty does not apply to any part of an Ultra-Fab PowerMover which has been subject to misuse, neglect, alteration, accident or damaged caused by fire, flood, or other damage caused beyond the control of Ultra-Fab.

In no event shall the manufacturer be liable for incidental or consequential damages. Some states do not allow the exclusion or limitation of incidental or consequential damages so the above limitation or exclusion may not apply to you.

Warranty does not include normal wear such as motor brushes, or wear caused by improper application. Parts covered under warranty shall be furnished without cost to the owner or user through an authorized dealer, or F.O.B. factory at Ultra-Fab's option. Ultra-Fab's liability under this warranty must be for part or parts, but not for such labor charges involved for removing and replacing defective parts.

In no event shall the owner be entitled to recover for incidental or consequential damages such as, but not limited to, loss of profit or revenue, other commercial losses, inconvenience or cost of rental or replacement equipment.

No responsibility is assumed for delays or failure caused by strikes, government regulations, or other circumstances beyond the control of the manufacturer or authorized dealer or distributor. Ultra-Fab Products assumes no liability for any damages that might be inflicted on the operator, spectator or general public who might be in the general area while this machine is in operation, or for any cause whatsoever.

It is the owner's responsibility to read and adhere to all caution and warning labels affixed to the Power Mover. Removal of original serial number voids this warranty in its entirety.

The Manufacturer does not authorize any person or company to create any Warranty obligation or liability on their behalf.
