



## ULTRA 5<sup>th</sup> WHEEL QUICK PIN

Heavy duty zinc plated steel construction spring loaded pin bolts allow you to quickly adjust landing gear legs. Fits 2 1/4" square landing gear legs. Bolts on. Available in 7/16" or 3/8" sizes.

### INSTALLATION



**IMPORTANT** – Block front and back trailer wheels so that trailer **CANNOT MOVE** in either direction.



**IMPORTANT** – Hook trailer to tow vehicle raising landing gear legs off of the ground.

1. Remove the existing landing gear holding pin in the middle tube and replace it with the **Ultra 5<sup>th</sup> Wheel Pin**. Attach the backing plate using both bolts and tighten the locknuts to a "snug" position. **DO NOT TIGHTEN COMPLETELY**. Repeat the installation process on the other leg.



**IMPORTANT** - Before lowering the load of your trailer onto the legs, make sure the **Ultra 5<sup>th</sup> Wheel Pins** are **FULLY ENGAGED** through **BOTH SIDES** of the outer tube. This will prevent possible damage and failure of the pins and possible damage to the **5<sup>th</sup> Wheel Landing Gear**.

2. With both **Ultra 5<sup>th</sup> Wheel Pins** snug and in place, lower the load of your trailer onto the legs. The legs will, and should, move slightly down on the brackets. With the load now completely back on the legs, tighten all 4 lock nuts approximately 1/4 of one turn from "snug" to "tight". **DO NOT OVER TIGHTEN**.
3. Now, once again, remove the load off the landing legs and check out the operation of your **Ultra 5<sup>th</sup> Wheel Pins** by adjusting the settings for the inner tube.
