

INSTALLATION/OPERATION

Ultra-Fab Leveling Blocks 48-979050, 48-979051, 48-979052

Step 1

Parking your RV

Position RV in the most level location of the site.

Step 2

Position UF Leveling Blocks

- Determine which wheels must be raised to level the RV. Always leave one wheel on the ground.
- Determine how high wheels need to be raised.
 Each UF Leveling Block will raise the wheel / RV by 1".
- Create a smooth area under the wheels to be raised by removing large stones and debris.
- Stack UF Leveling Blocks to the required height. (Sample configurations are shown below.)
- Place UF Leveling Blocks against the wheels to be raised.

Step 3

Drive RV Onto UF Leveling Blocks


- Slowly drive RV forward and move UF Leveling Blocks to position where tires were before moving forward.
- Slowly drive RV onto the top of the stack.
- If the vehicle is still not level, slowly drive RV off the stack and remove or add UF Leveling Blocks to achieve a level position.
- Slowly drive RV back onto the stack.
- Set the parking brake and turn off the engine.
- Proceed to secure and stabilize the RV depending on model and equipment available.


Step 4

Leaving Your Campsite


- Slowly drive RV off the stack of UF Leveling Blocks.
- Set the parking brake and turn off the engine.
- Retrieve the UF Leveling Blocks and return them to the nylon storage bag.




















Safety Warnings:

- Never position UF Leveling Blocks while vehicle is in motion.
- Ensure that all people are clear of the vehicle prior to moving it on to the stack of UF Leveling Blocks.
- Never crawl under the vehicle when UF Leveling Blocks are in use.
- Maximum stack height is 5". Do not exceed 5" stack height.
- When using under hydraulic jacks or fifth-wheel support jacks, always stack at least 2 blocks high.
- Do not use blocks upside down.

- 4) To obtain the benefits of this Warranty, you should return the product which you find defective to the Manufacturer named below during the period that this Warranty is in effect. All charges incurred in delivery of the product to the Manufacturer, and in picking it up after the Warranty service has been completed, must be paid by the Original Purchaser.
- 5) Any item returned in the manner described in paragraph 4 will be examined by the Manufacturer. If it is found that the returned item was defective in material or workmanship, the Manufacturer will repair it without charge for material and labor.
- 6) Ultra-Fab will pay freight on replacement parts during the first 90 days of ownership by the Original Purchaser.
